

What is a Park Master Plan:

- Documents Visions and Goals
- Identifies Land Use and Physical Improvements
- Provides Basis for Future Funding
- Represents Community Consensus



Definition of a Sports Complex:

- Serves Community-Wide Interests for higher intensity use facilities, such as baseball, softball, soccer, lacrosse, etc.
- Emphasis is on sport facility development, with some passive spaces
- Site should be relatively flat
- 20 acres or greater

Givens:

- The Larry Ochs Sports Complex park site shall be developed as a Sports Complex as identified in the City of Colorado Springs 2015-2025 Parks, Recreation & Trails Master Plan.
- The Larry Ochs Sports Complex site was purchased with Parkland Dedication Ordinance (PLDO) funding, for \$2.6 Million in 2003, expressly for the purpose of a sports complex.
- The Larry Ochs Sports Complex is zoned PK (Public Park).
- The project will be constructed as funds are available: The Scott Hall Field of Dreams Foundation (SHFOD) will be raising funds to pay for the construction of the Sports Complex



Givens:

- The facility will be designed to offer affordable recreational opportunities and be self sustainable for operation and maintenance of the Facility. (Revenue and expense neutral)
- The recommended master plan will be submitted to the Parks and Recreation Advisory Board for approval.
- Fish and Wildlife must approve any changes or impacts to Preble's Meadow Jumping Mouse Habitat
- Many groups and individuals are interested in and encouraged to help develop the best possible master plan for the Larry Ochs Sports Complex; all voices will be equal in the decision-making process.


Meeting Ground Rules:

Community Input from November's meeting: Issues/Concerns for the Team to Consider: (Group Responses)

- Access to Complex
 - Hours of operation, gated or ungated, alternative access
 - Capacity of Roads
- Traffic in Residential area
 - Noise, crowds, pollution
 - Parking overflow into Kettle Creek/Bison Ridge Neighborhoods
- Buffer between ball fields and Bison Ridge Neighborhood
- Decrease in property value
- Increased vandalism in neighborhood
- Community Park and Sports Complex – Definitions?
- Maintenance and Operations





Community Input from November's meeting: Issues/Concerns to address during the Process: (Individual Responses)

- Ingress/Egress – Volume of Traffic on surrounding roads
- Impacts on Wildlife
- Opportunities for Basketball Courts
- Gated park access
- Purchase Kettle Creek property for main access point
- Parking – sufficient amount within park
 - Will Bison Ridge be considered overflow parking
- Effect on property values
- Light, noise crowd pollution
 - How late will games be run and lights be on
 - Would like to see technology to reduce spill over in neighborhood
- Maintenance of fields for the long term
- Site Security – crime such as drug deals
- Property Values decreasing
- On-going Communication about the design of the Sports Complex
- Access from Powers Boulevard
- Concerned about participants in the meetings being rude and speaking out of turn
- Jogging Trail that would remain open
- Addition of Rugby, Lacrosse and football.

Traffic & Access:





Traffic Analysis

- Old Ranch - Minor Arterial
 - Carrying Capacity = 5,000 – 25,000 vehicles per day
 - Existing Volume = 6,700 vehicles per day
 - Projected Volume = 10,700 vehicles per day
- Chapel Ridge – Local Collector (wide enough for 3 lanes)
 - Carrying Capacity = 1,500 – 5,000 vehicles per day
 - Existing Volume = 1,100 vehicles per day
 - Projected Volume = 3,200 vehicles per day
- Future signalization of Chapel Ridge and Old Ranch intersection is anticipated



Design Features:

- Gated access at Roundabout that will be lit to discourage undesirable activities
- Developed portions of park designed as far from homes as possible. (Past the existing tree buffer)
- Lighting from fields will be a minimum of 700' from the closest resident.
 - Closest current light pole on Powers is 237'
 - Closest current light pole at Pine Creek is 1060' (not LED)
- Walking Paths throughout



Program Details

- 8 Diamonds / Multi Purpose Outfields
- 3 Multi-Purpose Fields
- 3 Concession Stand/Restroom Buildings
- Average of 60 Parking Spaces per field
- Passive Recreation Area
- Central Gathering Area (Warm-up, Picnics, Smaller Soccer Games)



Operation Plan:

- Operating entity will be a third party organization who will oversee the day to day operations of the park. They will be a contractor to the City of Colorado Springs
 - The operating entity will need to establish a sustainable operation model prior to construction commencing.
- Elements the operating manager will oversee:
 - Use of the fields: practices vs tournaments
 - Security during events
 - Hours of operations
 - Maintenance
 - On-Site Presence
 - Marketing of Facility
